## 3 PERMANENT SCHOOL FUND (PSF)

– ACRES: 14 MILLION

– ACRES: 2.6 MILLION

# *TYPES OF MINERAL OWNERSHIP*

## 3 PERMANENT SCHOOL FUND

### – FEE

- PSF OWNS MINERAL & SURFACE ESTATES
- ACRES: 5.8 MILLION

### – MINERAL CLASSIFIED-

### RELINQUISHMENT ACT LANDS (RAL)

- PSF OWNS 100% OF MINERAL ESTATE & HAS SOLD THE SURFACE ESTATE
- ACRES: 6.4 MILLION

# *TYPES OF MINERAL OWNERSHIP*

- PERMANENT UNIVERSITY FUND (PUF)
  - PRIMARILY FEE LANDS IN WEST TEXAS

- 3 TEXAS LAND COMMISSIONER, JERRY PATTERSON
- 3 GENERAL LAND OFFICE
- 3 BOARD FOR LEASE, TEXAS DEPARTMENT OF CRIMINAL JUSTICE
- 3 BOARD FOR LEASE, TEXAS PARKS & WILDLIFE DEPARTMENT
- 3 BOARD FOR LEASE, UNIVERSITY LANDS

# *PROCEDURES FOR LEASING*

## 3 PERMANENT SCHOOL FUND

### – FEE TRACTS

- LEASED BY SLB AT SEALED BID ON A BONUS BASIS
- SALES HELD QUARTERLY
- TRACTS NOMINATED BY INDUSTRY
  - NOMINATION LETTER SENT TO GEORGE MARTIN,  
TEXAS GENERAL LAND OFFICE
  - \$100 PER TRACT NOMINATION FEE
- EVALUATED BY GENERAL LAND OFFICE STAFF FOR MINERAL VALUE
- ADVERTISED IN “NOTICE FOR BIDS”
  - MAILED APPROXIMATELY 30 DAYS PRIOR TO SALE



# *PROCEDURES FOR LEASING*

## – FREE ROYALTY

- LEASED BY OWNER OF THE MINERAL ESTATE
- PSF RETAINS A FREE ROYALTY OF 1/8 OR 1/16
- COPY OF CERTIFIED LEASE TO BE FILED WITH GLO

# *PROCEDURES FOR LEASING*

- 3 TEXAS DEPARTMENT OF CRIMINAL JUSTICE (TDCJ)
  - LEASED BY BOARD FOR LEASE, TEXAS DEPARTMENT OF CRIMINAL JUSTICE
  - SEALED BID SALE HELD CONCURRENT WITH SLB SALE
  - TRACTS NOMINATED BY LETTER TO JESSE ARELLANO, TEXAS GENERAL LAND OFFICE
  - EVALUATED BY GLO STAFF FOR MINERAL VALUE
  - ADVERTISED IN “NOTICE FOR BIDS”

# *PROCEDURES FOR LEASING*

- LEASED BY BOARD FOR LEASE, TEXAS PARKS AND WILDLIFE DEPARTMENT
- SEALED BID SALE HELD CONCURRENT WITH SLB SALE
- TRACTS NOMINATED BY LETTER TO JESSE ARELLANO, TEXAS GENERAL LAND OFFICE
- EVALUATED BY GLO STAFF FOR MINERAL VALUE
- ADVERTISED IN “NOTICE FOR BIDS”

# *PROCEDURES FOR LEASING*

- 3 TEXAS DEPARTMENT OF TRANSPORTATION (TXDOT)
  - LEASED BY SLB UNDER TNRC 32.201 ET. SEQ.
  - TRACTS APPLIED FOR BY LETTER TO DREW REID, TEXAS GENERAL LAND OFFICE



# *PROCEDURES FOR LEASING*

- 3 PERMANENT UNIVERSITY FUND (PUF)
  - LEASED BY BOARD FOR LEASE, UNIVERSITY LANDS
  - SEMIANNUAL SEALED BID SALE
  - GENERALLY IN MAY AND OCTOBER
  - TRACTS NOMINATED BY INDUSTRY
  - EVALUATED BY UNIVERSITY LANDS DIVISION STAFF IN MIDLAND
  - FOR FURTHER INFO CONTACT JAMES HOLTZCLAW (432) 684-4404

## 3 MISCELLANEOUS ENTITIES

- LEASED BY SLB AT SEALED BID SALE
- TRACTS NOMINATED BY LETTER TO GEORGE MARTIN OR JESSE ARELLANO, TEXAS GENERAL LAND OFFICE
- EVALUATED BY GLO STAFF FOR MINERAL VALUE
- ADVERTISED IN “NOTICE FOR BIDS”

- LEASED BY SLB AT QUARTERLY LEASE SALE

## 3 STANDARD FORM

- FOR COPY OF LEASE OR OTHER INFO CONTACT RENEWABLE ENERGY DIVISION (512) 463-5042 OR 475-1372

# *GEOHERMAL ENERGY LEASE*

- 3 TERMS AND CONDITIONS
- SET BY SLB FOR EACH TRACT
  - TERMS FOR JULY 17 SALE
    - MINIMUM BONUS: \$2.00/ACRE
    - ANNUAL RENTAL: \$3.00/ACRE BEGINNING WITH THE SECOND YEAR OF THE LEASE, WITH THE EXCEPTION OF THE RENTAL DUE ON THE FIFTH ANNIVERSARY OF THE LEASE, WHICH WILL BE \$6.00/ACRE
    - PRIMARY TERM: TEN YEARS; 5 YEARS WITH OPTION FOR ADDITIONAL 5 YEARS
    - ROYALTY: 10% OF THE GROSS PROCEEDS DERIVED FROM AN ARM'S-LENGTH SALE

# *POOLING STATE LEASES*

- 3 STATUTORY AUTHORITY PROVIDED BY TNRC
- 3 SLB MUST APPROVE POOLING OF STATE LANDS
- 3 UNLEASED RIVERBEDS AND CHANNELS MAY BE POOLED
- 3 FILE FOR POOLING BY SUBMITTING APPLICATION TO GLO
- 3 \$100.00 APPLICATION FEE
